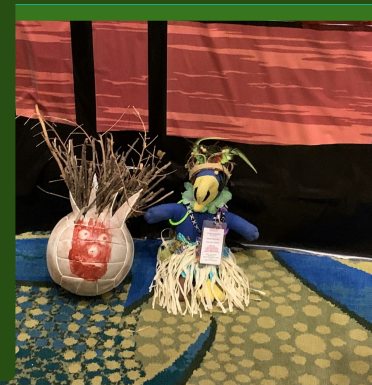
PARROT HEAD BOWLING-July 31!!!

Rain threatened, so we moved inside; but, it didn't dampen our spirits (or Eric's)!!! I think they're was something about Goat being "They"???

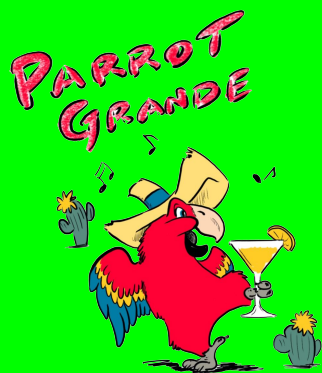


Erica Sunshine Lee-Aug 20



No rain for Erica and a wonderful time was had by all at the Holt Hacienda pool and soon to be bar!

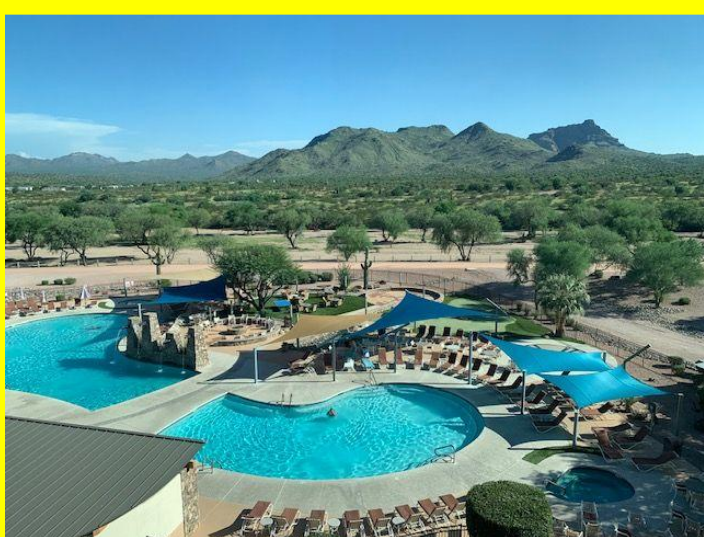

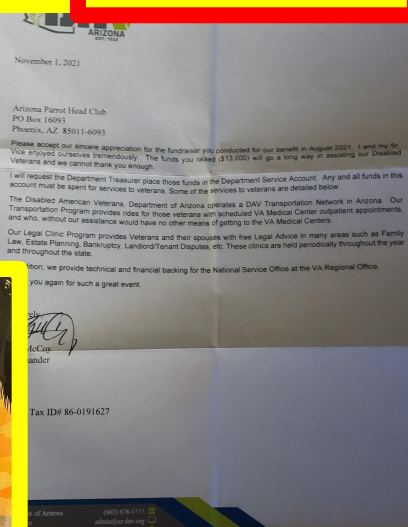

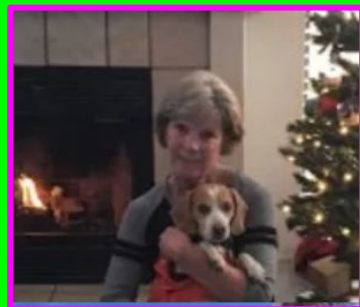
